

Dean Health Plan Musculoskeletal Care Management (MSK) Program Quick Reference Guide for Ordering Physicians/Surgeons Updated May 2021

Dean Health Plan's prior authorization process for inpatient and outpatient total knee arthroplasty and total hip arthroplasty is managed by Magellan Healthcare. Effective July 1, 2021, prior authorization will no longer be required for **outpatient** total knee arthroplasty and total hip arthroplasty procedures (CPT 27447 and 27130 only). Starting June 25, 2021, **inpatient** total knee arthroplasty and total hip arthroplasty prior authorization requests submitted with dates of service on and after July 1, 2021, will be reviewed for place of service (also referred to as site of care) in addition to the current review for medical necessity.

This program includes prior authorization for non-emergent inpatient and outpatient hip, knee, shoulder, lumbar and cervical spine surgeries. This decision is consistent with industry-wide efforts to ensure clinically appropriate quality of care and to manage the increasing utilization of these services.

Prior Authorization

It is essential that providers develop a process for those MSK services that require prior authorization to ensure that the appropriate authorization number(s) has been obtained.

It is the responsibility of the ordering physician/surgeon and rendering facility to ensure that prior authorization was obtained, when necessary. Payment will be denied (for professional and facility) for procedures performed without a prior authorization, which will include the MSK surgery hospital admission with the ordering physician/surgeon (1 authorization needed), and the member cannot be balance-billed for such procedures.

Procedures Requiring Prior Authorization *

Outpatient and Inpatient Spine Surgery Services (not changing):

- Lumbar Microdiscectomy
- Lumbar Decompression (Laminotomy, Laminectomy, Facetectomy & Foraminotomy)
- Lumbar Spine Fusion (Arthrodesis) With or Without Decompression – Single & Multiple Levels
- Cervical Anterior Decompression with Fusion –Single & Multiple Levels
- Cervical Posterior Decompression with Fusion –Single & Multiple Levels
- Cervical Posterior Decompression (without fusion)
- Cervical Artificial Disc Replacement
- Cervical Anterior Decompression (without fusion)

Outpatient and Inpatient Hip Surgery Services (place of service update): **

- Revision/Conversion Hip Arthroplasty
- **Inpatient Only** - Total Hip Arthroplasty/Resurfacing
- Femoroacetabular Impingement (FAI) Hip Surgery (includes CAM/pincher & labral repair)
- Hip Surgery – Other (includes synovectomy, loose body removal, debridement, diagnostic hip arthroscopy, and extra-articular arthroscopy)

Outpatient and Inpatient Knee Surgery Services (place of service update): **

- Revision Knee Arthroplasty
- **Inpatient Only** - Total Knee Arthroplasty (TKA)
- Partial-Unicompartmental Knee Arthroplasty (UKA)
- Knee Manipulation under Anesthesia (MUA)
- Knee Ligament Reconstruction/Repair
- Knee Meniscectomy/Meniscal Repair/Meniscal Transplant
- Knee Surgery – Other (includes synovectomy, loose body removal, diagnostic knee arthroscopy, debridement with or without chondroplasty, lateral release/patellar realignment, articular cartilage restoration)

**Surgeon must request surgery authorization for each joint, even if bilateral joint surgery is to be performed on the same date.

Outpatient and Inpatient Shoulder Surgery Services (not changing): **

- Revision Shoulder Arthroplasty
- Total/Reverse Arthroplasty or Resurfacing
- Partial Shoulder Arthroplasty/Hemiarthroplasty
- Shoulder Rotator Cuff Repair
- Shoulder Labral Repair
- Shoulder Surgery – Other (includes debridement, manipulation, decompression, tenotomy, tenodesis, synovectomy, claviclectomy, diagnostic shoulder arthroscopy)

Magellan Healthcare will manage non-emergent inpatient and most outpatient hip, knee, shoulder and spine surgeries through the existing contractual relationships with Dean Health Plan. If an urgent/emergent clinical situation exists outside of a hospital emergency room, please contact Magellan Healthcare immediately with the appropriate clinical information for an expedited review. Dean Health Plan providers should call Magellan Healthcare's Call Center at 1-866-307-9729 to obtain a prior authorization approval.

Prior Authorization Information

To ensure that authorization numbers have been obtained, please adhere to the following guidelines.

Outpatient and Inpatient Musculoskeletal Surgeries:

- Effective July 1, 2021, prior authorization will no longer be required for **outpatient** total knee arthroplasty and total hip arthroplasty procedures (CPT 27447 and 27130 only). Starting June 25, 2021, **inpatient** total knee arthroplasty and total hip arthroplasty prior authorization requests submitted with dates of service on and after July 1, 2021, will be reviewed for place of service (also referred to as site of care) in addition to the current review for medical necessity.
- Except for CPT 27447 and 27130, all other non-emergent outpatient and inpatient hip, knee, shoulder, and spine surgery services do require approved prior authorization through Magellan Healthcare.
- Emergency musculoskeletal surgery (admitted via the Emergency Room) does not require prior authorization through Magellan Healthcare. If admitted, inpatient admission notice to the Health Plan applies.
- The RadMD website at www.RadMD.com and Magellan HealthCare Call Center at 866-307-9729 will be available beginning June 25, 2021, for the new place of service program.
- The ordering physician must obtain prior authorization with Magellan Healthcare prior to performing the surgery. Additionally, the facility should ensure that a Magellan Healthcare prior authorization has been obtained prior to scheduling the surgery/procedure.
- Magellan Healthcare's medical necessity review and determination is for the authorization of the surgeon's professional services, place of service and type of surgery being performed. Magellan Healthcare will provide the Dean Health Plan with the surgery type requested and authorization determination.
- Authorizations are valid for 90 days from the date of service for outpatient surgeries that require prior authorization and 14 days from date of service for inpatient.

Intraoperative Findings

- If additional services, beyond those authorized, are rendered due to a finding during the surgery or a change in condition following the surgery, the surgeon is required to contact Magellan Healthcare's Call Center at 866-307-9729 within 7 business days of the date of the surgery. At that time, clinical information to support the medical necessity of the additional services will be required.

Checking Authorizations

To check authorization status, after logging in to the Magellan Healthcare portal at www.RadMD.com, select the **My Exam Requests** tab to **view all** outstanding authorizations.

Submitting Claims

Submit claims directly to Dean Health Plan. While Dean Health Plan will accept paper claims, providers are encouraged to submit claims electronically to expedite processing and reduce claim rejections.
