What is the overall <a href="#">deductible</a> ?	<p><a href="#">In-network provider</a>/services: \$500 individual/\$1,000 family</p> <p><a href="#">Out-of-network provider</a>/services: \$1,000 individual/\$2,000 family</p>	If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> . <a href="#">Deductible</a> exceptions include office visit <a href="#">copays</a> and for federally required <a href="#">preventive services</a> . The <a href="#">deductible</a> starts over with each plan year beginning on January 1 <sup>st</sup> .
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes. <a href="#">Preventive care</a> and primary care services are covered before you meet your <a href="#">deductible</a> .	This <a href="#">plan</a> covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. But a <a href="#">copayment</a> or <a href="#">coinsurance</a> may apply. For example, this <a href="#">plan</a> covers certain <a href="#">preventive services</a> without <a href="#">cost-sharing</a> and before you meet your <a href="#">deductible</a> . What is the <a href="#">out-of-pocket limit</a> for this <a href="#">plan</a> ?	<p><a href="#">Medical</a>: In-network providers <a href="#">Durable Medical Equipment</a> (in-network only): You pay 20% up to \$500 per individual</p> <p>Out-of-network providers \$4,000 individual / \$8,000 family</p> <p><a href="#">Prescription drug</a>: Level 1 and 2: \$600 Individual \$1,200 Family</p>	If you have other family members in this <a href="#">plan</a> , the overall family <a href="#">out-of-pocket limit</a> must be met. The <a href="#">out-of-pocket limit</a> is the most you could pay during a coverage period (usually one year) for your share of the cost of covered services. This limit helps you plan for health care expenses. The federal <a href="#">maximum out-of-pocket</a> is \$9,450 individual/\$18,900 family. This applies to all essential health benefits, including some services not included in the <a href="#">out-of-pocket limit</a> . (i.e. certain level 3 & 4 <a href="#">prescription drugs</a> and adult hearing aids covered under this <a href="#">plan</a> ).

<b>Will you pay less if you use a <a href="#">network provider</a>?</b>	Yes.
